Documents must be submitted at least 10 working days prior to the beginning of the semester you wish to attend to be considered for review. **Please allow 10 working days for document evaluation.**

- Documentation of possession of California vehicle license plates
- California voter registration
- Documentation of entry into a legal agreement in California (examples: marriage, divorce)
- Active Duty Military I.D., copy of orders in CA
- Recent Veteran: LES, DD214
- Out-of-State institution non-resident tuition receipt
- Immigration documents: VISA, I-94, change of status application verification
- Verification of California bank accounts
- Documentation of ownership of residential property or continuous occupancy of rented or leased property in California

- Utility bills (gas, water, power, telephone)
- Official high school or college transcripts
- Documentation of public assistance, rehabilitation, unemployment, or other state services
