5. **SEPARATION OR DIVORCE.**
6. **DEATH OF A SPOUSE OR PARENT.**
7. **DISCHARGED FROM ACTIVE MILITARY DUTY.**

The following must be submitted in a complete packet. **If an item does not apply to you, do not leave it blank. Enter zero or N/A.**

If based on federal guidelines you are considered a dependent student, you must provide the following information for both parents if they were both included on the FAFSA. If you are considered an independent student, and you are married, you need to provide the following information for you and your spouse.

1. Clearly explain the reason for the loss of income.

2. Provide documentation (i.e. letter of termination, statement from appropriate agency detailing loss of untaxed income, divorce decree, death certificate, DD214, etc.).

3. Provide a copy of your 2008 federal income tax return.
