Also, if you are living in any of these situations and fleeing an abusive parent you may be considered homeless even if your parent would provide support and a place to live.*
- *“Unaccompanied” means you are not living in the physical custody of your parent or guardian.*
- *“Youth” means you are 23 years of age or younger or you are still enrolled in high school as of the day you sign this application.*
