The following items are required for admission:

Sierra College's admission requirements meet all U.S. government regulations for issuing F-1 student visas. **Also any official transcripts and documents submitted will not be returned or copied.**

1. Prospective student must be 18 years of age and have successfully completed secondary school/high school.
2. Submit a complete Sierra College International Student Application.
3. Meet one of the following English language requirements below and provide copy of test score(s).
 - TOEFL scores must be at least 133 CBT (Computer Based Test), 450 PBT (Paper Based Test), or 45 IBT (Internet Based Test). Please request your original TOEFL score report; our TOEFL code is 4697.
 - IELTS – 5.0 minimum test result.

The English language requirement is waived if you come from a country that uses English as the primary language in its educational system. (We do not accept institutional TOEFL scores; TOEFL scores are for admission ONLY. Upon arrival, students will take assessment tests to determine placement in appropriate courses).

4. Submit a copy of a current official bank statement/letter (translated to English)

Cannot be dated not older than three months of submission to Sierra College indicating there is a minimum of \$17,000 U.S. dollars available to cover tuition and expenses. If you will be bringing dependents, an extra amount of \$5,000 U.S. dollars for an accompanying spouse and \$2,000 U.S. dollars for each accompanying child will be added to that minimum amount required.

If you are being supported financially by a sponsor (ex: family member or government), you will be required to submit a completed I-134 document.

5. Submit official transcripts translated into English

Transcripts must indicate successful completion from a secondary school, equivalent to completion of an American high school. Also, submit transcripts from any other college or university you have attended.

6. Submit a copy of your valid passport (photo page).

7. Submit the non-refundable application processing fee of \$100. Payment is accepted by the following methods:
 - MasterCard or Visa
 - Check/Money Order

Transfer Students—additional admission requirements:

If you are currently attending another college, university or other educational institution in the United States, you must also submit the following:

1. Copies of your visa and I-20 from your current college/institution.
2. Submit Sierra College Transfer Clearance Form, completed by the college you are currently attending. This form is available on Sierra College's website.
3. Official college transcripts from all college, universities, or other educational institutions you've attended in the United States.

Health insurance:

In the United States, health care can be costly. All international students must purchase medical insurance from Sierra College's carrier. **There are no exceptions** – even if you have health insurance in your home countries. Medical insurance enrollment materials will be provided to you prior to your arrival.

You will receive an admissions decision within three weeks after all documents have been received and reviewed. Applications that are not complete (including all required supportive documents) by the application deadline will be deferred to the next available semester.

If approved for admission to the Sierra College International Program, you will be issued and mailed an I-20. You will use the I-20 to apply for an F-1 Student Visa at the U.S. Consulate or Embassy in your country.
