RESOLUTION OF THE GOVERNING BODY OF THE

DECLARING AN ELECTION BE HELD IN ITS JURISDICTION;  
REQUESTING THE BOARD OF SUPERVISORS TO CONSOLIDATE THIS ELECTION WITH

REQUESTING ELECTION SERVICES BY THE COUNTY CLERK.

WHEREAS, this District Governing Body orders an election to be held in its jurisdiction on November 8, 2022; at which election the issue(s) to be presented to the voters shall be:

1. Said election shall be to fill a vacancy for the following Board Member(s) who resigned and/or whose term(s) expired:

- The cost of the Candidate Statement shall be paid by the **Candidate**.

5. Said District has determined the following election particulars:
  - In the case of a tie vote, the election shall be determined by **LOT** by the respective county elections officials.
  - The County Clerk is **requested** to provide election services. If the District requests the Placer County Elections Division to provide election services, all applicable costs will be paid for by the District.

BE IT RESOLVED that the Board of Supervisors of the County of Placer; Board of Supervisors of the County of Nevada; Board of Supervisors of the County of Sacramento; and the Board of Supervisors of the County of El Dorado are hereby requested to:

1. Consolidate the election with any other applicable election conducted on the same day;
2. Authorize and direct their respective County Clerk/Elections Officials, at Governing Body expense, to provide all necessary election services, which shall include, but not be limited to publications, issue nomination documents, ballots, sample ballots, election officers, polling places, and canvass.

This Resolution shall be considered a Notice of Election and Specification of Election Order if applicable.

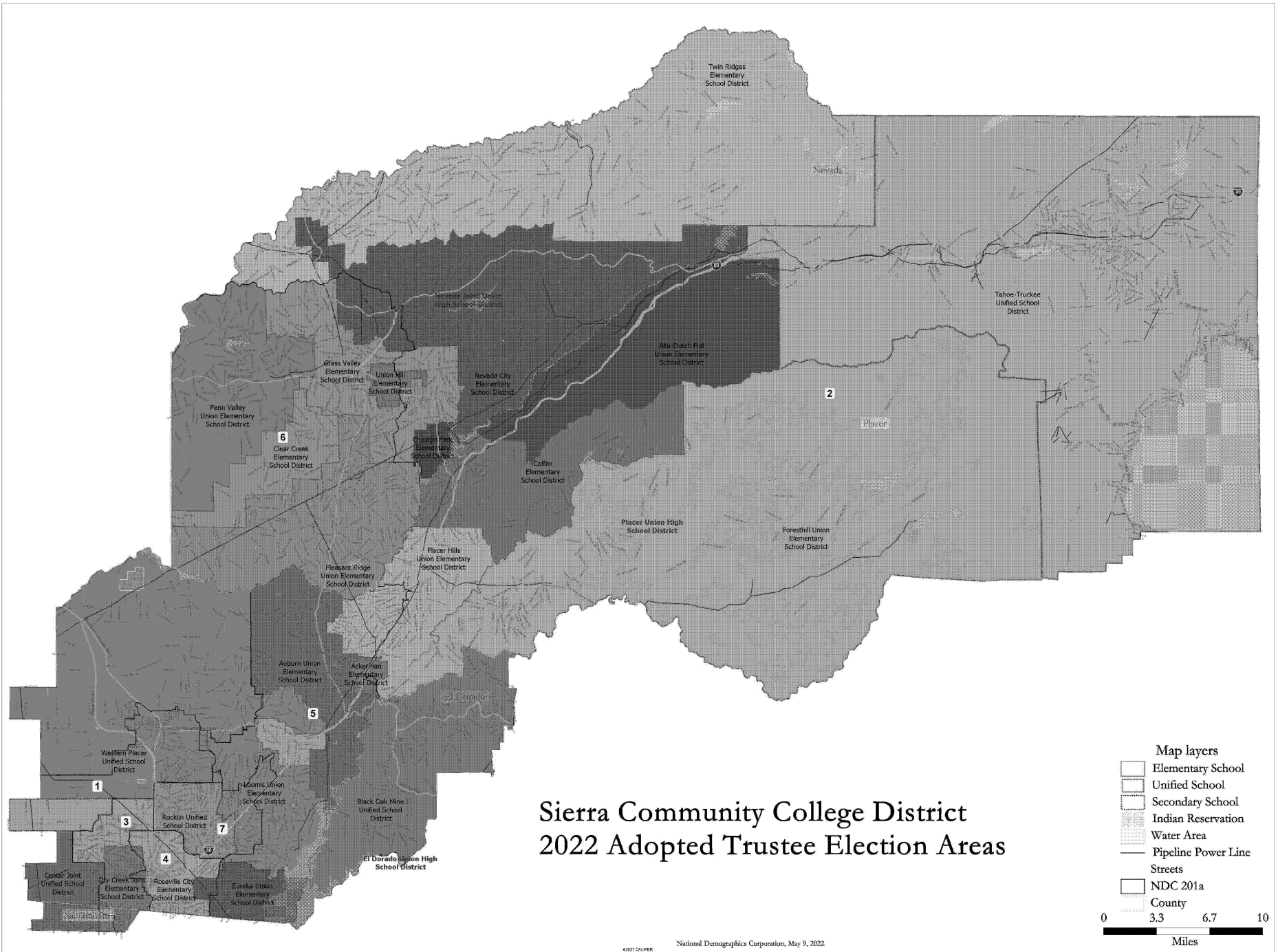
