### Collections Access

The Sierra College Archives are part of and are housed in the Sierra College Learning Resource Center/Library on the Rocklin campus. The Sierra College Archives includes historical materials related to college history and governance. The archival materials are organized by date and topic and are subject to the same cataloging requirements as all other collections in the library. The materials located in the Sierra College Archives are non-circulating. The collections may be used during regularly scheduled office hours or through special arrangement. Materials may not be checked out or leave the room. All individuals utilizing the archival materials will sign a document (“sign-in sheet”) upon entrance that includes an agreement to indemnify the Sierra Community College District from suit in the event of copyright infringement by the user.

### Copyright Statement

The collections of the Sierra College Archives (content including images, text, and audio and video recordings) are made publicly available for use in research, teaching, and private study.

The nature of historical archival and manuscript collections often makes it difficult to determine the copyright status of an item. It is the user's exclusive responsibility to use an item according to the terms governing its use.

If the copyright is held by another entity, please contact the collection-holding repository and/or copyright owner for additional available information regarding copyright status of a particular image, text, or audio or video recording.

## **Conditions of Use**
